Approve the participation of Morgan Park High School in French Exchange and authorize expenses related to the program.

PROGRAM: In conjunction with its World Language & International Studies Program, Morgan Park High School will send twelve (12) students to France from May 8, 2001 through May 22, 2001. The program in language immersion and comparative cultures includes a fifteen-day exchange component in France, which will be hosted by families of students attending our "sister" school, Centre International de Valbonne in the city of Valbonne, France. Host families are selected by French exchange teachers taking every precaution to insure student security and safety. Nine of the Morgan Park High School students traveling to France are enrolled in Honors French II and three students are enrolled in Honors French I. They will be accompanied by Mrs. Donna Castelli, French & English Teacher and Mrs. Mary Kennedy, World Social Studies Teacher. Mrs. Castelli and Mrs. Kennedy will be on paid leave to chaperone an educational and cultural foreign exchange.

EDUCATIONAL VALUE/OUTCOMES: Students in the World Language & International Studies Program at Morgan Park High School study a curriculum which focuses on a global perspective in education. The curriculum emphasizes oral fluency in foreign language and development of an awareness of cultural differences. During the field extension of their classroom studies, students will have the opportunity to explore cultural institutions and historical sites as they experience language immersion and contemporary French life and culture. The student and their teachers will follow a prescribed itinerary of school visits and field trips to Nice, and surrounding communities, i.e. Eze, Cannes, Antibes, etc.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Arrangements for this program are being made by MiCES, Inc., Marcia Hochberg, 1200 North Lake Shore Drive, Suite 702, Chicago, IL 60610, 1-312-944-3690.

COST: The per pupil cost is \$1,275.00 which includes transportation, certain meals, hotel accommodations, trip cancellation insurance. Health and accident insurance will be provided by the Board of Education. The costs will be paid by the individual participants.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 97-1217-PO1 ("Policy on Student Travel"), including proper ratio of students to adults.
