EDUCATIONAL VALUE/OUTCOMES:

- The festival will provide experiences that will motivate the students toward a career in music performance.
- They will gain exposure to cultural diversity and enrichment through their performance and the performance of the other choirs.

COST: The cost per student is \$500.00 which includes transportation, meals, hotel costs, health and accident insurance, trip cancellation insurance, etc. The total cost for this trip is \$25,000. The All-City Performing Arts Parent Group will provide \$17,282.00 through fund-raising efforts. The balance of \$8,750.00 will be provided by the Bureau of Cultural Arts.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board report 97-1217-PO1 ("Policy on Student Travel"), including proper ratio of students to adults.

James S. Hammond, music teacher and principal conductor, Gabrielyn Watson, music teacher and assistant conductor, Saundra Brown, music teacher and piano accompanist, LaDonna Myers, music teacher, Brad Raymond, music teacher, Shannette Rooks, teacher, Donald Baumgartner, teacher and Rose Tate, parent will accompany the students.

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at the Bureau of Cultural Arts for each student and staff member participating in the tour.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.
