SCOPE OF SERVICES: The consultant provided four (4) two and one half hour sessions at each of the 26 Schools in Region 3 and Dunbar High School in Region 4 to improve students' reading abilities. The 10 hours were scheduled into four sessions: Understanding Present Skills, Breaking Old Habits and Learning New Skills, Improving Comprehension and Recall and Four Steps to Faster Reading and Better Comprehension.

DELIVERABLES: Consultant taught approximately 120 teachers and 1,600 students for 2.5 hours per day, Tuesdays through Fridays.

**OUTCOMES:** Students increased their initial reading rate by 2,3, or 4 times with better comprehension.
