## **DESCRIPTION:**

**Grant:** Grant to Local School

Funding Source: National Endowment of the Humanities

Receiving Unit: Kenwood Academy H.S.

Amount: \$145,000

**Purpose:** This project involves faculty at Kenwood Academy and The University of Chicago who will use the history and diversity of Chicago to develop new curricula in English, U.S. history and Music. By viewing the history of Chicago as the imaginative construction of writers, artists, musicians and scholars, this project will develop web-based humanities courses that bring students into this process of construction. Using internet technology and Chicago's scholarly and cultural institution, Kenwood Academy teachers will devise curricula that meet and exceed Illinois Learning Standards in History and English.

Funding Period: 2001 -2004
