PAYMENT PERIOD: Payments are authorized for university courses provided from December 2001 through August 31, 2002.

PROGAM DESCRIPTIONS: Funds obtained through a recent Department of Education appropriation will be used to send teachers in the Magnet Cluster Initiative to university courses that will result in full certification, endorsement, or a graduate degree. In some cases, the funds will cover a full program, such as a series of courses that results in full endorsement, while in other cases the funds will be used to pay for a single course. Universities will be paid directly by the Office of Academic Enhancement. The Office of Academic Enhancement will fund only those courses that have been pre-approved by the curricular administrators working for the Office of Academic Enhancement.

OUTCOMES: Through this program, each school in the Magnet Cluster Initiative will have two or more teachers taking or having taken courses to improve their teaching strategies in the magnet program area of focus or another curricular area closely related to the magnet program area of focus. This will increase the quality of instruction at the schools, resulting in the following: increased student achievement, as measured by the lowa Test of Basic Skills (ITBS) or Test of Achievement and Proficiency (TAP); increased student motivation in the classroom; and increasing the number of students eligible to apply to Chicago public high schools that have selective admission requirements.

AFFIRMATIVE ACTION: Pursuant to Section 3.7 of the M/WBE Plan, this contract is exempt from review under the M/WBE Plan, due to the fact that this expenditure is for tuition payments.
