TERM: The term of this license agreement shall be for a period of ten (10) months commencing September 1, 2001 and ending June 30, 2002.

USE: To be used by Hubbard High School, 6200 S. Hamlin to provide parking spaces. Licensee shall be restricted to use of the lot Mondays through Fridays between the hours of 8:00 a.m. - 5:00 p.m. Ingress and egress shall be from the alley at 62^{nd} Place and Hamlin.

LICENSE FEE: During the term of the License, Licensee shall pay a license fee of \$4,000.00 payable in monthly installments of \$400.00

OPERATION & MAINTENANCE: Licensee shall maintain the Premises in its current condition or better throughout the term of the License and at the expiration of the License, the Premises will be turned over in the same condition as received. Licensee shall keep the Premises free of all debris, bottles and trash at all times at the sole expense of the Licensee. Licensee shall also be responsible for snow removal during the times when Licensee uses the Premises.

Indebtedness - The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics - The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability - The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
