TERM: The term of the agreement shall commence on the date the agreement is signed and shall end twenty-four (24) months thereafter. The agreement shall have three (3) options to renew for periods of one (1) year each. The cost of the agreement will be negotiated at the time of each renewal.

EARLY TERMINATION RIGHT: Thirty days written notice by the Board of Education.

SCOPE OF SERVICES: Vendor will print the Educator Newspaper as requested by the Department of Communications staff. Vendor will also work with staff on an as needed basis in designing, proofreading, delivering and storing of the Educator newspaper.

**DELIVERABLES:** Vendor shall print the Educator Newspaper.

**OUTCOMES**: Vendor's services shall result in the quality printing of the Educator Newspaper.

**COMPENSATION:** The vendor will be paid based on the number of publications of the Educator in amounts to be specified in this contract, total not to exceed \$400,000.00.

**AUTHORIZATION:** Authorize the General Counsel to include other terms and conditions in the written agreement. Authorize the President and Secretary to execute the agreement. Authorize the Chief Purchasing Officer to execute all ancillary documents required to administer or effectuate this agreement.

AFFIRMATIVE ACTION: The products and services to be delivered by this vendor is subject to the provisions of the Revised Remedial Plan for M/WBE Economic participation. Every good faith effort will be made by this vendor to achieve compliance with the applicable goals.

## **GENERAL CONDITIONS:**

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one-year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
