PROGRAM: This is the eighth grade trip that is in conjunction with the Social Studies curricula. Visiting Washington D.C. will provide the eighth grade students with an overview of how our government works an understanding to our nation's laws, a preview of the major historical sites, visiting various memorials, and touring museums.

EDUCATIONAL VALUE/OUTCOMES: The tour activities are in keeping with the goals of the eighth grade curriculum. In addition, the objective of this tour is to enhance students' awareness of knowledge gained in the classroom in the areas of United States History and Politics. A detailed itinerary has been established to ensure that students will gain an invaluable experience, which will solidify prior knowledge and promote interest for future classroom activities.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.

AFFIRMATIVE ACTION: Not applicable.

LSC REVIEW: Eli Whitney Local School Council approved the tour on September 4,2002.

FINANCIAL: No cost to the Chicago Public Schools.

GENERAL CONDITIONS:

Ethics- The Boards Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of any agreement.

Contingent Liability- Any agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
