AUTHORIZE CONTINUED RETENTION OF THE LAW FIRM FOLEY & LARDNER

THE GENERAL COUNSEL REPORTS THE FOLLOWING DECISION:

Continued retention of the law firm Foley & Lardner.

DESCRIPTION: The General Counsel previously engaged the law firm Foley & Lardner to represent the Board in litigation filed by the Chicago Teachers Pension Fund concerned alleged deficiencies in payments made to the Fund by the Board for the benefit of certain categories of employees. Active settlement negotiations are underway in this litigation. In addition, the firm is utilized on an ongoing, as-needed basis to provide legal consultation and opinions regarding pension and tax issues that arise in connection with the Board's financial transactions. Additional authorization for the firm's services are requested in the amount of \$25,000. As invoices are received, they will be reviewed by the General Counsel and, if satisfactory, processed for payment.

Ethics - The Board's Ethics Code adopted September 27, 1995, (95-0927-RU3), as amended from time to time, is hereby incorporated into and made a part of the agreement.

Contingent Liability - The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
