RESOLUTION: DESIGNATE FOR ACQUISITION CERTAIN REAL PROPERTY FOR THE CONSTRUCTION OF THE NEW MILES DAVIS SCHOOL

WHEREAS, the Board of Education of the City of Chicago (the "Board") is a body corporate and politic organized and existing under and by virtue of the provisions of the Illinois School Code, 105 ILCS 5/34-1 et seq., as amended (the "Code"); and

WHEREAS, the Board exercises general supervision and jurisdiction over the establishment and maintenance of public schools, educational and recreational facilities of the Board; and

WHEREAS, the Board has determined that the property (the "Property") described in Exhibit A is required for school, educational and recreational purposes, specifically for the construction of a new Miles Davis School; and

WHEREAS, Section 5/34-20 of the Code authorizes the acquisition of title to real estate by purchase, condemnation or otherwise, for school purposes, such title to be held for the use and benefit of the Board in the name of the City of Chicago in Trust for the Use of Schools; and

WHEREAS, it is necessary, desirable, useful and advantageous, and in the best interests of the citizens of the City of Chicago to acquire the Property for school, educational and recreational purposes.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the members of the Chicago Board of Education as follows:

- 1. It is necessary, desirable, useful and advantageous, and in the public interest to acquire fee simple title to, and possession of, the Property for school, educational and recreational purposes.
- 2. The Board hereby approves the acquisition of title to the Property for the construction of a new Miles Davis School.
- 3. The Board further authorizes and directs the General Counsel or her designee, for and on behalf of the Board, to negotiate with the owner or owners of the Property for the purchase of the Property.
- 4. If an agreement can be reached with the owner or owners of the Property regarding the purchase price to be paid, authorization is hereby granted to purchase the Property subject, however, to final approval by the Board.
- In the event that the negotiations for the purchase of the Property do not result in a mutually agreed amount of compensation to be paid therefore, then title to and possession of the Property may be acquired by the Board through condemnation, and the General Counsel is hereby authorized, empowered and directed to institute or direct institution of proceedings in a court of competent jurisdiction to acquire title to and possession of the Property by the Board in accordance with the eminent domain laws and procedures of the State of Illinois and in the manner provided by Article VII of the Code of Civil Procedure.
- 6. This resolution is effective immediately upon its adoption.
