**PROGRAM:** Waters school will send thirty-five (35) eighth-grade students to Washington, D.C. from April 8, 2004, through April 10, 2004. This marks our tenth anniversary multilingual-multicultural historical trip.

**EDUCATIONAL VALUE/OUTCOMES:** Waters eighth-grade tour is the culminating cultural and historical activity to our yearly social independent studies of our nation's capital, our governing institutions, our historical perspectives, our historical monuments, our elected representatives, the branches of government, and the value of our democracy. Our students keep journals of their journey. They collect samples for their student portfolios. They develop, research, and present their historical perspective of the trip.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Arrangements for this program are being Educational Tours.

COST: The per pupil cost is \$598.00 which includes transportation, meals, hotel accommodations, health and accident insurance coverage providing protection against bodily injury or death. Each student will pay \$360.00 and the school will pay \$238.00 for each student using discretionary funds.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 03- 0527- PO01 ("Policy on Student Travel"), including proper ratio of students to adults. Traveling with students will be Mr. Thomas E. Revollo, (principal), Ms. Titla M. Kipp (assistant principal), Ms. Olga Marquez (teacher), Ms. Wendi Allen (teacher), Ms. Martene Anzueta (teacher), and Ms. Maureen Connelly (teacher).

**PARENTAL CONSENT:** Written parental consent and release forms for each student are on file at Thomas J. Waters Elementary School.

**AUTHORIZATION:** Authorize the President and Secretary to execute any travel agreements necessary for this program.
