PROGRAM: The program "High School Spanish" integrates morning Spanish classes with a complete set of afternoon cultural, social, and sports activities. On weekends, students are able to travel to other important Spanish cities in the south, as a means of complementing their in-class learning. The classes, as well as the materials used and programmed activities, are especially geared toward younger students. As part of the total immersion program, students enjoy carefully selected housing in the form of family home stays.

## **EDUCATIONAL VALUE/OUTCOMES:**

- To build personal, cultural, and global awareness
- To generate more interest in the Spanish language, culture, history and traditions
- To build confidence in communicative skills with a different language and culture
- To provide experiences in a different culture
- To be able to recognize and appreciate similarities and differences between culture

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Arrangements for this program are being made by Janet Torres.

**COST:** The per pupil cost is \$2,500. which includes transportation, meals, hotel, cost, health and accident insurance, etc. The costs will be paid by instituto San Fernando.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report (03-0527-PO01) (Policy on Student Travel), including proper ratio of students to adults. Touring with the students will be Janet Torres (teacher), and Robert Blease (teacher).

**PARENTAL CONSENT:** Written parental consent and release forms for each student are on file at Northside College Prep High School.

**AUTHORIZATION:** Authorize the President and Secretary to execute any travel agreements necessary for this program.

**AFFIRMATIVE ACTION:** Not applicable.

## **GENERAL CONDITIONS:**
