## APPROVE ENTERING INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE CHICAGO HOUSING AUTHORITY TO FUND A TRANSPORTATION PROGRAM FOR STUDENTS RELOCATED BY THE CHA

## THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into an intergovernmental agreement (IGA) with The Chicago Housing Authority (CHA) to fund a transportation program designed to help students who are relocated under the CHA transformation during the 2004-2005 school year to continue attending their school of origin at no cost to the Board. A written IGA is currently being negotiated. The authority granted herein shall automatically rescind in the event that an IGA is not executed within 120 days of the date of this Board Report. **TERM:** The term of this IGA shall commence upon execution of the agreement and it shall continue until June 30, 2005.

**BASIC TERMS OF THE IGA:** As specified in the IGA, CHA shall tender payments to the Board totaling \$75,000 to fund a transportation program designed to help students who are relocated under the CHA transformation during the 2004-2005 school year to continue attending their school of origin if those students are moved more than 1.5 miles from their school of origin. The Board shall purchase and provide to CHA-approved students who are subsequently enrolled in the program by the Board's Homeless Education Program Manager, Chicago Transit Authority (CTA) student fare cards and one CTA adult fare card per family if an enrolled student is in the 6<sup>th</sup> grade or under. The Board shall enroll student families on a first come, first served basis until all funds to be provided by CHA under the IGA have been allocated by the Board's Homeless Education Program Manager.

**AUTHORIZATION:** Authorize the General Counsel to include other relevant terms and conditions in the IGA. Authorize the President and Secretary to execute the IGA. Authorize the Chief Specialized Services Officer to execute all ancillary documents required to administer or effectuate the IGA.

## **GENERAL CONDITIONS:**

Ethics – The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.
