PROGRAM: Students from Northside Prep will spend 8 days studying history in Poland through first hand accounts. These students will be engaged in daily educational activities, including visits to camps, ghettos, and universities throughout their stay in Poland. They will prepare during the current school year through film, readings, research, and first hand survivor accounts of the atrocities committed during this period in history.

EDUCATION VALUE/OUTCOMES: The students at Northside College Prep will be preparing for this trip throughout the school year in different facets. They will have a strong knowledge of WWI, WWII, and the atrocities committed during the Holocaust. It is important for their generation to understand what has happened in history and be able to carry the survivors' words and lives into the future. Soon, we will not be able to have first hand accounts of this period in our history, and it is up to the younger generation to help us learn from mistakes made in history and work to help prevent these atrocities like discrimination and hatred to flourish. Students will not only visit ghettos and camps in Krakow, Warsaw, and Lublin, but will also discover the beauty and culture of Poland. Some of the sites included in our trip are: Wawel Cathedral, the Museum of Jewish History and Culture, Auschwitz, Birkenau, Majdanek, Warsaw's Jewish Ghetto and Krakow University. Upon returning home from the trip, students will compile their experiences into presentations for our school and community. The purpose of this trip is to allow these high school students to experience this time in history, both where it happened and also with the people whose lives were affected during this terrible time in our history. These students will be able to carry the legacy of the survivors back to the United States, to Chicago, with the hopes of reaching out to others to make sure history doesn't repeat itself.
