PROGRAM: Students will enjoy 4 nights in Paris and 3 nights in Madrid while immersing ourselves in the languages and cultures of 2 major European nations. The first night is on the plane to Europe. The next 4 nights are in a 3-star hotel in the heart of Paris. The next night is on a train to Spain. Then we will have 3 nights in Madrid. On our 5th day we take an excursion to the suburb of Paris for the Palace of Versailles and Marie-Antoinette's hamlet on the grounds of this site of the signing of the treaty that ended World War I. In addition, we'll visit sites in Toledo on the 8th day.

EDUCATIONAL VALUE/OUTCOMES: The outcome for the students taking this trip is two-fold; learn about other cultures and enhance their language skills. Opening one's eyes to a whole new culture is invaluable.
