PROGRAM: Students will have the opportunity to travel throughout Costa Rica while adding to their knowledge of Spanish. Students will first travel to Alajuela, Costa Rica to participate in a Spanish Language Immersion Program through *The Learning Trips*. The trip will continue on to the Soto Ranch in Morravia de Chirripo, the Arenal Volcano region, Guanacaste and return to Alajuela. At each location, the students will receive daily group language classes with no more than five participants. All teens are placed in-group classes according to their language ability. The students will also participate in a variety of cultural activities at each location.

EDUCATIONAL VALUE/OUTCOMES: The students who are able to participate in this program will benefit greatly in terms of language learning and cultural knowledge.
