PROGRAM: Jones students are interested in exploring poverty and social conditions in Kingston, Jamaica. Specifically, this trip will seek to explore how the social conditions of African Americans and Jamaicans overlap. Students will explore the following: government and religious practices, economy, social cultural justice issues that impact the quality of life of Jamaicans and education. Students will explore mores, laws, folkways and norms of the Jamaican culture. Students will document the travel by using journals, a photograph album and camcorders. Students will return with an understanding of the Jamaican culture and share their new knowledge in Mr. McHenry's American Literature course and Mr. Dixon's Sociology class; furthermore, they will also share their experiences gained in Jamaica at the African American Club's Celebration of Blackness assembly on February 25th. In correlation with the Jones Strategic plan, students will become more aware of diversity and social cultural justice issues that impact Jamaican culture.

**EDUCATIONAL VALUE/OUTCOMES:** Upon returning to Chicago, students will be involved in a service learning project in which they will share their learned experiences with the Jones community. Students will utilize their photos, journals and camcorders to share their experiences with the Jones community. The following topics will be reported on by students:

- 1. Economic and Religious Affiliations of Jamaicans
- 2. Folkways and Norms of Jamaican culture
- 3. Political and Social Conditions of Jamaicans

**TRAVEL ARRANGEMENTS/TRIP INFORMATION:** Students and staff persons will be flying Air Jamaica airlines and will be residing at Immaculate Conception Convent located at 152 Constant Spring Rd. in Kingston, Jamaica. Sister Mary Grace Yap is the contact person and the director of the convent

**COST:** The price per student is \$750.00 which includes transportation, meals, hotel, costs, health and accident insurance, trip cancellation insurance, etc. The costs will be paid by students and donors and The African American Club- Jones account

**CHAPERONES:** Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel") is including proper ratio of students to adults.

Traveling with the students will be Joseph Dixon (teacher) and William McHenry (teacher).

**PARENTAL CONSENT:** Written parental consent and release forms for each student are on file at Jones College Preparatory.

**AUTHORIZATION:** Authorize the President and Secretary to execute any travel agreements necessary for this program.
