PROGRAM: Mark T. Skinner's Dance Club is a group of academically accelerated females wherein students will participate in multicultural dance which includes ballet, jazz, modern, hip hop, and dance choreography. Participation in this after-school Dance Club requires maintaining academic standards in the school, a team building and cooperative spirit, a high sense of self-worth, and an ability to learn dance. The Program involves thirteen students who compete in the Midwest Universal Dance Association's Summer Camp. The winning teams advance to the National Dance Competition held February 3rd through February 7th in Disney World's Sports Complex, Orlando, Florida.

EDUCATIONAL VALUE/OUTCOMES: Students who participate in Dance Club are given the opportunity to apply their knowledge and skills that demonstrate proficiency in creative movement and team building. National Dance Competitors also participate in workshops - choreography, team building, and new dance skills – and receive personal docent tours of Disney's exhibits – El Rio Del Tiempo, Impressions De France, O Canada, Reflections of China, Kilimanjaro Safaris, Maharajah Jungle Trek, Discover Island Trails, Boneyard, Conservation Station, and Cretaceous Trails. (State Goals 12B3a & 3b, 18A2, 19A3-4, 19B3-4, 21, 25A3a & 4a, and 26A2a & 3a & 4a, 26B2a & 3a & 4a)

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Travel to Orlando, Florida will be made by airplane. Ground transportation will be provided by buses and/or shuttles. (See attached for proposed itinerary.)

COST: The cost per pupil is \$788.00 which includes transportation, meals, hotel, admissions, health and accident insurance, and trip cancellation insurance. The costs will be paid by monies from student fees (\$688), and fundraising (100 per person).

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel"), including proper ratio of students to adults.

Traveling with the students will be Elizabeth Wardanian (Teacher), Lorel Madden (Parent), Sandra Perry (Parent), Lorie Vick (Parent), Marcia Alexander (Parent), and Mitzie Coaker (Parent).

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at Mark T. Skinner School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.

FINANCIAL: No cost to the board.

GENERAL CONDITIONS:
