PROGRAM: This is the eighth grade trip that is in conjunction with the Social Studies curricula. Visiting Washington D.C. will provide the eighth grade students with an overview of how our government works an understanding to our nation's laws, a preview of the major historical sites, visiting various memorials, and touring museums.

EDUCATIONAL VALUE/OUTCOMES: The tour activities are in keeping with the goals of the eighth grade curriculum. In addition, the objective of this tour is to enhance students' awareness of knowledge gained in the classroom in the areas of United States History and Politics. A detailed itinerary has been established to ensure that students will gain an invaluable experience, which will solidify prior knowledge and promote interest for future classroom activities.

PARENTAL CONSENT: At Eli Whitney School there will be on file for each child participating in the tour a written parental consent and liability release forms. The parents and or legal guardians of eighth grade students were surveyed via letter. Parents were also informed of the trip on report card pick-up November 19, 2005. Parents are in support of this trip and its destination.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.
