APPROVE SABBATICAL LEAVE AGREEMENT FOR APPOINTED TEACHER, LINDA L. MCGLIN, MARSHALL H.S.

THE CHIEF EXECUTIVE OFFICER RECOMMENDS THAT THE BOARD OF EDUCATION OF THE CITY OF CHICAGO:

Approve sabbatical leave of absence for Linda McGlin, appointed teacher, for the period of September 1, 2006 to June 30, 2007 and entry into a Sabbatical Leave agreement with Linda McGlin in accordance with the Board of Education's Sabbatical Leave Policy (Board Report # 05-0824-PO7) and as more fully set forth below.

DESCRIPTION:

Linda McGlin meets all of the eligibility requirements for a sabbatical leave and her sabbatical leave shall be subject to the following terms, which are consistent with the Board of Education's Sabbatical Leave Policy.

<u>Eligibility.</u> Linda McGlin is eligible for a Sabbatical Leave because she 1) is an appointed teacher 2) has completed six (6) or more years of continuous satisfactory service as a teacher; 3) she has not been granted a sabbatical leave under this Policy or its predecessor in the previous six (6) years; and 4) her position is budgeted for period of the sabbatical leave and she is not otherwise subject to layoff or reassignment under the Reassigned Teachers Policy or other applicable Board policies.

<u>Sabbatical Leave Plan Approval.</u> The Chief Education Officer and the School Principal have approved Linda McGlin's Sabbatical Leave plan to travel to the State of Tennessee in a Mathematics program of study. No change in the plan shall be made except in accordance with the Sabbatical Leave Policy.

Agreement for continued service at the conclusion of leave. As a condition of the leave, Linda McGlin shall agree in writing that if she fails to return to service at the expiration of the sabbatical leave for a period of at least two (2) years after the expiration of the leave, she shall refund all sums of money paid to her by the Board of Education during her sabbatical leave.

Pay During Sabbatical Leave. Linda McGlin shall be paid her basic salary, less a deduction of the cost to the Board for providing substitute service during the sabbatical leave. If Linda McGlin engages in any activity for which she will receive salary or compensation from another employer during the sabbatical leave, the equivalent of that salary or compensation shall also be deducted from her basic salary. If any salary earned during the sabbatical leave activity is greater than or equal to Linda McClin's salary minus substitute pay, Linda McGlin shall receive no pay during the leave. Linda McGlin is obligated to report to the Department of Human Resources any compensation he receives from another employer during the period of the sabbatical leave.

<u>Proof of Compliance with the Terms of the Sabbatical Leave</u>. Linda McGlin shall submit proof of compliance with the Sabbatical Leave plan in accordance with the requirements of the Sabbatical Leave Policy.

<u>Form of Agreement.</u> Upon approval of this Board Report by the Board of Education Linda McGlin's application for Sabbatical Leave dated December 15, 2005 and approved by the Chief Education Officer, the Sabbatical Leave Policy and this Board Report shall constitute the agreement between the Board of Education and Linda McGlin. The Board enters that agreement based upon the foregoing representations. If any of those representations are inaccurate, the Board may declare a breach of the agreement and seek repayment of any sums paid under the agreement or pursue other remedies provided in the Sabbatical Leave Policy. Upon approval of this Board Report, the Department of Human Resources shall transmit a copy of the approved Board Report and the Sabbatical Leave Policy to Linda McGlin.

Revocation of the Sabbatical Leave. The sabbatical leave may be revoked in accordance with the Sabbatical Leave Policy.

LSC REVIEW:

Linda McGlin is not an assistant principal or a contract principal; therefore LSC review or approval is not required.

FINANCIAL:

Linda McGlin shall be paid her basic salary, less a deduction of the cost to the Board for providing substitute service during the sabbatical. If Linda McGlin engages in any activity for which she will receive salary or compensation from another employer during the sabbatical leave, the equivalent of that salary or compensation shall also be deducted from her basic salary. If any salary earned during the sabbatical leave activity is greater than or equal to Linda McGlin's salary minus substitute pay, Linda McGlin shall receive no pay during the leave. Linda McGlin is obligated to report to the Department of Human Resources any compensation she receives from another employer during the period of the sabbatical leave.
