THE CHIEF EXECUTIVE OFFICER RECOMMENDS THE FOLLOWING DECISION:

Approve the renewal of the Charter School Agreement with Perspectives Charter School for an additional 5-year period. A new Charter School Agreement applicable to this renewal term is currently being negotiated. The authority granted herein shall automatically rescind in the event a written Charter School Agreement is not executed by the Board and the charter school's governing board within 120 days of the date of this Board Report. The renewal agreement authorized herein will only take effect upon certification by the Illinois State Board of Education. Information pertinent to this renewal is stated below.

In the fall of 2004, Perspectives Charter School expanded into a new facility located at 1930 South Archer Avenue in order to accommodate their education programs. As of June 30, 2005, their lease on 1915 South Federal Street terminated and Perspectives will conduct all school activities at the Archer facility. This amended Board Report is necessary to authorize this change in address as well as an increase in the maximum student enrollment to permit up to 400 pupils. A written amendment to the Charter School Agreement is required. The authority granted herein shall automatically rescind in the event a written amendment is not executed by the Board and the Perspectives' governing board within 120 days of the date of this amended Board Report. The amended agreement authorized herein will only take effect upon certification by the Illinois State Board of Education.

This amendment is necessary to authorize Perspectives Charter School Agreement to establish an additional campus located at 8131 S. May Street (Calumet HS) and to increase the school's enrollment cap by 756.

This third amendment is necessary to increase the initial enrollment number and change the initial grades of the high school campus that Perspectives will open in the fall of 2006 at 8131 South May Street. The enrollment number and grades will change from 216 students in grades 6 and 9 to 270 students in grades 7 and 9.

This fourth amendment is necessary to approve Perspective Charter School's proposal submitted March 31, 2006 to establish two additional campuses to open in the Fall of 2007, which additional campuses and corresponding changes to enrollment are contingent upon the renewal of the Charter School Agreement with Perspectives Charter School. Contingent upon said renewal, Perspectives Charter School would a) operate two new campuses at the Calumet location in the Fall of 2007: a middle school campus and a technology high school campus b) change the grades served in the Fall 2007 at the Perspectives Charter School-Calumet Campus from 7-10 to 9-10 c) decrease the enrollment capacity for the high school campus that opened in Fall 2006 from 756 students to 500 students, and d) increase the total enrollment capacity of Perspectives Charter School to 1900 students. No amendment to the Charter School Agreement is required.

ORIGINAL AGREEMENT: The original Charter School Agreement (authorized by Board Report 97-0122-EX4) is for a term commencing July 1, 1997 and ending June 30, 2002. The agreement authorizes the operation of a single facility Charter School focusing on college preparation and character development for students in grades 6-12. The school is located at 1532 S. Michigan with current enrollment of approximately 275 students. The Agreement incorporates an accountability plan whereby the school is evaluated by the Board each year based on numerous factors related to its academic, financial and operational performance.

CHARTER RENEWAL PROPOSAL: The Perspectives Charter School submitted a renewal proposal on September 10, 2001 to continue the operation of the school under the same mission and educational programs at a new location, 1736 S. Michigan. Perspectives' Material Modifications proposal requests an increase in the maximum student enrollment to permit up to 400 pupils. Perspectives' submitted a Material Modifications proposal on May 20, 2005, to request an amendment to their Charter School Agreement, which would authorize the school to move to a new facility at 1930 South Archer Avenue and to increase its maximum student enrollment to permit up to 400 pupils.

The Perspectives Charter School submitted a Renaissance 2010 proposal on August 19, 2005 and a material modification application in November 2005 to request an additional high school campus at 8131 S. May Street (Calumet HS). The material modification also requested an increase in the enrollment cap by 756. The additional campus will open in the fall of 2006 with 270 students in grades 7 and 9. In successive years, this new campus will add additional students and grow to serve grades 7-12 not to exceed 756 students. This proposal was reviewed for appropriateness specific to the community by the Calumet Transition Advisory Council (TAC). A public hearing, as required by statute, was held on October 3, 2005. An additional public hearing was held at Calumet H.S. on Tuesday, November 8, 2005. During the 2006-2007 school year, Perspectives Is authorized to operate two campuses, one at 1930 South Archer and the other at 8131 South May, with enrollments respectively of 400 students and 270 students. The enrollment for the new campus at 8131 South May will grow to 756 at capacity, and the total enrollment cap for both Perspectives campuses will be 1,156. The cost of 270 students in 2006-2007 will be approximately \$1,545,750. These budget figures are based on the revised per pupil funding amounts released on August 31, 2005.

Perspectives Charter School submitted an additional Renaissance 2010 proposal to establish a third high school campus that would open in Fall 2007. This proposal is currently under evaluation, and if approved by the Board, the campus would also be located at 8131 S. May Street (Calumet HS) and would serve 216 students in grades 6 and 9 in Fall 2007 and grow to serve grades 6-12, but not exceed 756.

On March 31, 2006, Perspectives Charter School submitted a proposal to a) establish two additional campuses at the Calumet location in Fall 2007 (1) Perspectives Charter School-Calumet Middle School Campus and (2) Perspectives Charter School-Calumet School of Technology, b) to change the grades served in Fall 2007 from 7-10 to 9-10 and decrease enrollment capacity from 756 students to 500 for Perspectives Charter School-Calumet Campus and c) to increase the total enrollment capacity of Perspectives Charter School from 1156 to 1900 students in the Fall of 2007 with a total of four campuses.

The Perspectives Charter School-Calumet Middle School Campus is anticipated to open in Fall 2007 with 375 students in grades 7-8 and may serve up to 500 students in grades 7-8. The Perspectives Charter School-Calumet School of Technology is expected to open in Fall 2007 with 200 students in grades 9-10 and may serve up to 500 students in grades 9-12. The Perspectives Charter School-Calumet Campus opening in Fall 2006 will initially serve grades 7 and 9. In Fall 2007, the campus is expected to serve 200 students in grades 9-10 and in successive years may serve up to 500 students in grades 9-12.

The enrollment capacity for Perspectives Charter School in Fall 2007 is expected to increase by 744 students to 1900 students. In 2007-2008, the cost of 505 additional students will be approximately \$2,893,750. These budget figures are based on the revised per pupil funding amounts released on August 31, 2005. A public hearing, as required by statute, was held on April 27, 2006. The addition of the Calumet campuses in Fall 2007 and changes to enrollment are contingent upon the renewal of Charter School Agreement with Perspectives Charter School upon the expiration of this renewal term ending on June 30, 2007.

CHARTER EVALUATION: The Charter School's Office Review Committee ("Committee") has reviewed and evaluated Perspective's renewal proposal as well as the school's past academic, financial and operational performance. During the last school year, Perspectives met all of its academic, financial and operational accountability requirements that are measured by the Board under the original agreement. The Committee recommends, based on these accountability measures and results, that Perspectives Charter School be authorized to continue operating as a charter school.

RENEWAL TERM: The term of Perspective's charter status is being extended for five (5) years commencing July 1, 2002 and ending June 30, 2007.

AUTHORIZATION: Authorize the General Counsel to include relevant terms and conditions, including any indemnities to be provided to the charter school, in the written Charter School Agreement which shall reflect resolution of any and all outstanding issues between the Board and the governing body of the charter school including, but not limited to: site location, enrollment, funding, educational program, financial controls and practices, academic accountability and evaluations. Authorize the President and Secretary to execute the Charter School Agreement. Authorize the Director of Charter Schools to issue a letter notifying the Illinois State Board of Education of the action(s) approved hereunder and to submit the approved proposal and signed Charter School Agreement to the Illinois State Board of Education for certification. Authorize the General Counsel to further negotiate and execute any amendments to the Agreement as required by the Illinois State Board of Education.

LSC REVIEW: Approval of Local School Councils is not applicable to this report.

AFFIRMATIVE ACTION: Not applicable

FINANCIAL: The financial implications will be addressed during the development of the 2006-2007 fiscal year budget. Since the School Code of Illinois prohibits the incurring of any liability unless an appropriation has been previously made, expenditures beyond FY06 are deemed to be contingent liabilities only, subject to appropriation in subsequent fiscal year budgets.

GENERAL CONDITIONS:

Inspector General – Each Party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts- The agreement shall not be legally binding on the board if entered into in violation of the Provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one-year period following expiration or other termination of their terms of office.

Indebtedness- The Board's indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics- The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.
