PROGRAM: To provide educational experiences outside the classroom and to enhance its Social Studies, Science, Math, and Writing Programs, William E. Dever will have 130 students participate in an all day tour of downtown Chicago.

EDUCATIONAL VALUE/OUTCOMES: Students at William E. Dever participate in rigorous curriculum which can be enhanced by exploring the City of Chicago. Multi-cultural education will be enhanced at Dever School by participating in this educational tour. Students will have a better understanding and experience a real life connection to Illinois history, government, and science through the primary and secondary research within the curriculum. As a result of this trip, the students will gain an increased knowledge of the everyday workings of the City of Chicago and make a connection to their lives.
