PROGRAM: Two hundred eighty-eight (288) cadets and 37 instructors will participate in training activities at Volk Field in Wisconsin, August 20, 2007 thru 24 August 2007. The school is designed to educate and train all JROTC Programs Cadet Leaders in preparation for the upcoming school year. The intent is to build individual and team leadership attitudes and skills and prepare SY 2007- 2008 goals, briefings, strategy and staffing skills. Training will be conducted in 12 small groups of 24 cadets with two military instructors who will facilitate, mentor and coach each group. The program will also be enhanced with performance oriented training, extracurricular activities (sports competitions, leader reaction/team exercises) and motivational speakers to reinforce learning objectives.

EDUCATIONAL VALUE/OUTCOMES: The objective of the Cadet Command and Staff Leadership School will provide cadets an opportunity to develop leadership skills and participate in team building exercises. Cadets participate in strategic planning, problem solving and staff training activities.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Arrangements for this program are being made by the Military Area Office. Cadets and JROTC instructors will travel by bus transportation provided by Treasured Tours.

COST: The cost of the camp is \$ 35,000 which includes transportation and meals. The costs will be paid by the Military Area Office.
