# APPROVE EXERCISING THE FIRST OPTION TO RENEW THE AGREEMENTS WITH VARIOUS PROVIDERS TO PROVIDE SOCIAL, EMOTIONAL AND EDUCATIONAL CONSULTING SERVICES (SEL #1)

#### THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the first option to renew the agreements with various providers to provide Social, Emotional and Educational consulting services to the Office of Specialized Services at a cost for the option period not to exceed \$684,000.00 \$236,600.00 in the aggregate. A written renewal document exercising this option is currently being negotiated for each provider. No payment shall be made to any provider during the option period prior to the execution of such provider's written renewal document. The authority granted herein shall automatically rescind as to each provider in the event that a written renewal document for such provider is not executed within 90 days of the date of this amended Board Report. Information pertinent to this option is stated below.

Of the original group of thirty providers, two (2) opted not to renew their agreements and the Board opted not to renew an additional (10) agreements, as those providers were not utilized during the original term.

This amended Board Report is necessary to increase the maximum program costs during this option period from \$114,000.00 to \$684,000.00 in the aggregate and reflect the additional appropriation of \$570,000.00 from Federal-Department of Education, Safe Schools Healthy Students funds committed to this project.

This second amended Board Report is necessary to decrease the maximum program costs during this option period from \$684,000.00 to \$236,600.00 in the aggregate and reflect the decrease in the amount of Federal-Department of Education, Safe Schools Healthy Students funds committed to this project as the funds are now committed to a future Social, Emotional and Educational Consulting Services Board Report pending RFQ approval. This second amended Board Report also is necessary to do the following: (i) accurately reflect the legal name of Management Planning Institute (MPI, Inc.); (ii) update the name and/or contact information for 4 Providers; and (iii) expand the approved categories for Youth Guidance and SGA Youth and Family Services.

**ORIGINAL AGREEMENT:** The original Agreements (authorized by Board Reports 04-0922-PR34, as amended by Board Report 05-0223-PR7 and Board Report 05-0824-PR20) are for a term commencing September 22, 2004 and ending August 31, 2007, with the Board having two options to renew for periods of one year each. The original agreements were awarded on a competitive basis pursuant to a duly advertised Request for Qualifications (Specification Number 04-250075), and they have an aggregate value not to exceed \$1,501,355.00

**OPTION PERIOD:** The term of each agreement is being extended for one year commencing September 1, 2007 and ending August 31, 2008.

OPTION PERIODS REMAINING: Each agreement has one option period of one year remaining.

**SCOPE OF SERVICES:** Each provider has been approved to furnish services in one or more designated categories (see Exhibit A). Services include the following:

# Category E: Program Evaluation

**DELIVERABLES:** Providers shall continue to furnish evidence-based, age-appropriate training to Board staff and services to CPS students.

**OUTCOMES:** Provider services shall continue to result in the following:

- 1. Increased student social/emotional competencies.
- 2. Implementation of proven practices to promote social/emotional learning by Board staff.
- 3. Increase availability of support services for students and their families in high need areas.
- 4. Increased capacity of the Board to provide training opportunities for school staff in high need areas.

**COMPENSATION:** Each provider shall be paid a negotiated rate for services as detailed in each provider's renewal agreement. Compensation shall not exceed \$684,000.00 \$236,600.00 in the aggregate for the one year extension term.

**AUTHORIZATION:** Authorize the General Counsel to include other relevant terms and conditions in the written renewal agreements. Authorize the President and Secretary to execute the renewal agreements. Authorize the Chief Specialized Services Officer to execute all <u>Statements of Work and amended Statements of Work, and all</u> ancillary documents required to administer or effectuate these renewal agreements.

**AFFIRMATIVE ACTION:** Pursuant to Section 5.2 of the 2007 Remedial Program for Minority and Women Owned Business Enterprise Participation in Goods and Services Contracts (Program), a determination shall be made as to when transactions should be excluded from contract specific M/WBE goals. It has been determined that the participation goal provisions of the Program do not apply to transactions where the pool of providers includes not-for-profit organizations.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
