**WHEREAS,** on January 24, 2007, the Board adopted a Policy on the Governance of Alternative and Small schools, Board Report 07-0124-PO2 ("Governance Policy");

WHEREAS, The schools on the attached list operate with ALSCs or Boards and each school's ALSC or Board recommended in a public session the names of parents, community residents or advocates to fill vacancies on the ALSC or Board and submitted the recommendations to their Area Instruction Officer ('AIO") for consideration in accordance with the Governance Policy;

WHEREAS, The principals of the schools on the attached list also submitted to their AlO recommended candidates for the vacancies on their school's ALSC or Board and the AlOs submitted these names and the names submitted by the ALSCs or Boards, and any additional recommended candidates, to the Chief Executive Officer for consideration in accordance the Governance Policy;

WHEREAS, the Governance Policy authorizes the Chief Executive Officer to recommend to the Board the names of individuals to fill vacant seats on ALSCs and Boards from any of the names submitted or any other names identified by the Chief Executive Officer;

**WHEREAS,** in accordance with the Illinois School Code, 105 ILCS 5/34 2.4(b), and the Governance Policy, the names of the following individuals have been forwarded to the Board for its consideration in its exercise of absolute discretion in making appointments to ALSC or Boards:
