Authorize the first and second renewal agreements and new agreements with various vendors to provide Safe Haven Sites and Services in various sites/locations at an estimated annual cost set forth in the Compensation Section of this report. New Vendors were selected through supplemental Requests for Qualifications (RFQs): Specification #19-350038 was advertised and awards recommended for seven (7) additional vendors, listed below as #38 to #44; Specification #20-350023 was advertised and awards recommended for two (2) additional vendors, listed below as #45 to #46. Written option documents for the existing 37 Vendors and written agreements with the nine (9) new Vendors selected through the supplemental RFQs are currently being negotiated. No payment shall be made as to each existing Vendor during the option periods prior to execution of that Vendor's written option document. No services shall be provided and no payment shall be made as to each new Vendor prior to execution of that Vendor's written agreement. The authority granted herein shall automatically rescind in the event a written document is not executed within 90 days of the date of this Board Report. ORIGINAL AGREEMENT:

The original Agreements (authorized by Board Report 19-0626-PR7) in the amount of \$1,900,000 are for a term commencing July 1, 2019 and ending June 30, 2020, with the Board having two (2) options to renew for one (1) year terms. The original agreements were awarded on a competitive basis pursuant to Board Rule 7-3. The term of the original Agreements was extended by a no-cost extension approved by the Chief Procurement Officer pursuant to Board Rule 7-13(e), for a term commencing July 1, 2020 and ending August 31, 2020.

OPTION PERIOD:

The term of each agreement awarded pursuant to Specification #19-350014 is being renewed for two (2) years commencing September 1, 2020 and ending August 31, 2022.

TERM OF NEW AGREEMENTS:

The term of each agreement awarded pursuant to the supplemental RFQs is for an initial two (2) year term commencing September 1, 2020 and ending August 31, 2022.

OPTION PERIODS REMAINING:

There are no option periods remaining.

EARLY TERMINATION RIGHT:

The Board shall have the right to terminate each Agreement with 30 days written notice.

SCOPE OF SERVICES:

Vendors shall provide sites and services to elementary and/or high school students in up to 46 different sites/locations during designated time periods throughout the school year in the targeted communities. Vendors shall include workshops on study skills, conflict resolution, anger management, character building, and positive communication and provide safe places for the students to go after school, during summer, winter and spring breaks, and whenever there are any emergency services that are needed during the year.

OUTCOMES:

Vendors' services shall result in the following outcomes: (1) Students likelihood to participate in violent behavior or become a victim of violence is reduced. (2) Parents are provided childcare support during daytime hours while students receive educational enrichment activities including: problem solving, positive communication strategies, anger management strategies, and discussions about violence in the community, guidance regarding truancy prevention, and tutoring in a safe environment during non-school hours.

COMPENSATION:

Vendors shall be paid during the term as specified in their respective agreement: Estimated annual costs for the two (2) year term are set forth below:
