

AMEND BOARD REPORT 25-0424-PR7
AUTHORIZE A NEW AGREEMENT WITH VARIOUS VENDORS FOR CUSTOM PRINTING SERVICES
AND PROMOTIONAL ITEMS

THE SUPERINTENDENT/CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Authorize a new agreement with various vendors to provide custom printing services and promotional items to all units at an estimated annual cost set forth in the Financial Section of this report. Vendors were selected on a competitive basis pursuant to Board Rule 7-3. Written agreements for Vendors' goods and services are currently being negotiated. No goods or services shall be provided or ordered and no payment shall be made to Vendors prior to the execution of their written agreement. The authority granted herein shall automatically rescind in the event a written agreement is not executed within 90 days of the date of this Board Report. Information pertinent to this agreement is stated below.

This August 2026 amendment is necessary to add twenty (20) new Vendors to the list of pre-qualified Custom Printing Services and Promotional Items vendors pursuant to the First (1st) Supplemental Request for Qualifications #25-1073 ("Supplemental RFQ"). In addition, STAPLES INC. DBA STAPLES CONTRACT & COMMERCIAL LLC and SUNRISE HITEK GROUP LLC will be removed from the list of pre-qualified vendors due to their failure to sign the original contracts.

TERM:

The term of this agreement shall commence on May 1, 2025 and shall end on April 30, 2028. This agreement shall have two (2) options to renew for periods of one (1) each.

The term of this qualification period for the supplemental vendors being added pursuant to the Supplemental RFQ is commencing September 1, 2026 and ending April 30, 2028.

EARLY TERMINATION RIGHT:

The Board shall have the right to terminate this agreement with 30 days written notice.

The vendors shall provide custom printing services for District Offices and Schools in the categories for which they have been pre-approved. The categories are listed below.

Vendors' services will result in cost effective custom printing services.

AUTHORIZATION:

Authorize the General Counsel to include other relevant terms and conditions in the written agreement. Authorize the President and Secretary to execute the agreement. Authorize the Chief Procurement Officer to execute all ancillary documents required to administer or effectuate this agreement.

BUSINESS ENTERPRISE PARTICIPATION:

Pursuant to the Remedial Policy for Minority-Owned Business Enterprise (MBE) and Women-Owned Business Enterprise (WBE) policy participation in Goods and Services contracts the aspirational Business Diversity goals for this pool are 30% MBE and 15% WBE. The supplemental will be adding (twenty) 20 additional vendors with five (5) MBEs and two (2) WBEs. This vendor pool is composed of 57seventy-five (75) total vendors with 19twenty-three (23) MBEs and 10twelve (12) WBEs. The User group has committed to achieve the Business DiversityEnterprise Development aspirational goals through a strategic plan to utilize certified suppliers and certified subcontractors.
